Kevin Regan, Assistant General Manager, and Rockard Delgadillo, former Los Angeles City Attorney, discussed the background experience of Hugo E. Pérez as a professional soccer player. The Board and Department staff also discussed the Scope of Services included in the proposed Personal Services Contract (Contract) with Hugo E. Pérez for soccer instruction, marketing, community outreach, consulting, and other services in relation to the establishment of a youth soccer program. Commissioner Alvarez requested that the proposed Contract include a detailed Scope of Services with specific deliverables on the amount of training sessions for coaches and Department staff, amount of Department staff members to be trained, and deliverable dates for the completion of the coach and soccer official training manuals. Commissioner Alvarez further requested that the compensation be tied to benchmarks based on completed deliverables. The Agenda Item was continued with instruction to staff to bring back an amended Board Report and proposed Contract that incorporates the contract term of one (1) year from the date of execution, a detailed Scope of Services with specific deliverables as discussed, and performance metrics for which to base the compensation according to completed deliverables.
