## CALL TO ORDER

### **APPROVAL OF THE MINUTES**

President Patsaouras called for a motion to approve the Regular Meeting Minutes of October 1, 2020. Commissioner Halper made such motion and it was seconded by Commissioner Bayne. There being no objections, the motion was unanimously approved by a vote of 4-0.

## **GENERAL PUBLIC COMMENTS**

Public comments on matters within the Board's jurisdiction were invited, 4 such requests were submitted.

Commissioner Nicole Chase joined the meeting during General Public Comment.

#### **GENERAL MANAGER'S UPDATE**

Michael A. Shull, General Manager, updated the Board on the Alternative Learning Sites program that is currently being held at more than 50 Recreation Centers with approximately 1,321 participants. Mr. Shull announced that RAP has started reopening nearly half of its 415 playgrounds, following County Health Department guidelines. He also shared that 1,379 City employees have applied for the Separation Incentive Program, and 164 of those are part of the RAP family. Mr. Shull stated that these retirements will affect operations, as those employees will not be immediately replaced, but the separations will be phased through March or April of next year. He also commended Belinda Jackson, Executive Director of EXPO Center, for her hard work organizing a new joint Park Advisory Board to serve at Gladys and San Julian Park. Mr. Shull thanked Ms. Jackson for her efforts in continuing to offer services at these parks.
