You knew about the pellet shelter housing motion and you blatantly lied to us by telling us this was only a "temporary" location because of the PANDEMIC. OVER AN OVER you said, "they can't be relocated during a pandemic". The worst thing is we believed you!

Simply housing these homeless is not the answer, they need much more: mental health and substance abuse services. Councilmember Kevin de Leon has not reached out to the residents and business owners of Eagle Rock. He does not know all of our opinions, nor has he taken into account our concerns. I know a lot of neighbors throughout ER who have emailed him/called him, but he never responds. He doesn't live in ER and he is lying to himself if he thinks his "A Way Home" plan will be successful long term.

I hope no one else overdoses at the parking lot, the count is now up to four.





The park entrances have nothing to do with who is responsible for the bulk of Debs, as much as you might wish it so.

Wanted to update you with the news that I have spoken with both Debs Park Ranger Larry Khou and Senior Park Ranger Frank Berhans (sp?) within the last 24 hours specifically regarding the Machete Man and destruction of habitat in Debs.

Apparently, they are now actively trying to locate this person and his sidekick but because the rangers go out later in the morning have been unable to find Messrs. Mass Destruction. I was able to give them specific info regarding the location & times these people tend to be out, which is a lot earlier (6:45-8 a.m. give or take) than they usually patrol so we'll just have to see how this plays out.

In addition, I did receive information from Ranger Khou that last week's fire did originate in the camp behind Debs/convalescent home and is essentially burned out with no one there (at least at his last patrol). There is supposedly a park-wide clean up scheduled for next week, but I have no further clarification on when specifically or what we might expect going forward with maintenance and squatting in the park.

Thus concludes today's Debs Park update. I commend both rangers for calling, asking pertinent questions and listening carefully to me. I do understand this is a massive undertaking with many plates spinning in the air.



I understand your frustration and appreciate you reaching out with your concerns. While I don't have answers to many of your questions, I do want to let you know that we are working on reopening Stoner Park safely.

As you mentioned, Stoner Park is undergoing renovations as well as hosting summer camp, extended care, and youth basketball, volleyball, tennis, and flag football. Hello,

I am a WLA resident who lives around the corner from Stoner Park. **Last October** the City of Los Angeles closed Stoner Park. The sign said it was closed until the beginning of the year for some improvements.

**FIVE MONTHS LATER** in March I contacted CD11 Mike Bonin's office for an update and they had none. I contacted **Parks and Rec in April** and there was no clear answer about the park reopening. I contacted **Mike Bonin's office again in May** and was cc'ed to Parks and Rec and **ONLY** received a response via phone after I threatened to contact my journalism colleagues to do a story on the parks closure and lack of response from the city.

**In JUNE** I was told by a part-time employee at Stoner park told me he wasn't familiar with all the reasons it was closed. He did say that there was going to be a walk-through after they laid new sod. Then it would be about 2 weeks until the park reopened. That was **6 weeks ago**.

The park closure and reopening have been **TERRIBLY communicated** by the Parks and Recreation Department and CD11. There's a website and Twitter account which you all use to promote all kinds of things but nothing about park closures and openings. If this is the case for Stoner Park, how many other residents are being given the run around by the city about access to community green spaces?

Last Sunday as I rode my bike past the park to take pictures of the gate I spoke with an elderly couple who expressed similar concern about the extended closure of this park and the lack of communication about it from the city.

As a longtime resident of the community, I am disheartened that I have had to damn near become a nuisance to get people to do their jobs and communicate **BASIC** information about this park.

There are Seniors in the community who live alone who don't have access to green space, children who are out of school this summer, and folks who have been locked inside for over a year due to the COVID19 pandemic that can't access this space. Folks who are depressed and folks who **SHOULD** be able to enjoy the California sunshine in a greenspace near their home.

Enough is enough.

I can't wait to get an update. If not I will choose the **BEST** folks in the neighborhood to interview for reporters, pundits, and influencers.

I think there was definitely an impact made when the rangers came a few weeks back and the unleashed dog crowd thinned out for a couple weeks and we saw people getting to enjoy the park again. That said slowly but surely the regulars are coming back. We have witnessed LAPD drive by the park slowly (not en route to an emergency) and do nothing with 8+ dogs off-leash in the park. They don't even do the basic minimum of getting on their loudspeaker and telling people to leash up. It contradicts the work the rangers are doing, the work Keith/Oakwood has been trying to do. Last week my neighbor also witnessed what seemed to be someone verbally berating an Oakwood Park staffer when the staffer asked the owners to leash their dogs. Some people are now letting their dogs run free but keeping the leash attached to the dog so they can say "the dog ran away"...it's all nonsense.

Some of the repeat people have been identified from the neighborhood as they have been coming every day for over a year. We have names for some people (they live in the neighborhood) , have photos of owners and license plates when people drive up and decide Oakwood is a dog park. Can citations be sent or warning letters? We have been told this would happen in the past to help let people know this violation is being taken seriously? Are there more patrols coming from the rangers, animal control, and LAPD? Yesterday 7:30-8:30 AM there were 9 dogs off-leash. This AM there were also roughly 11 dogs off-leash and a couple that got into the childrens playground area.

I have spent the week taking my dog to Westminster (about 1 mile from Oakwood), Santa Monica Airport park (1.7 miles), and Glen Alla (2 miles) and I have met plenty of dog owners who obey the laws and do the responsible thing.

The off-leash dog owners know the rules. Inconsistent enforcement (or LAPD not holding the line when they drive by) will not make a permanent impact.

Curious as to what the plan is moving forward with citations and patrol. Without some sort of consistency nothing will change. There was definitely a change in the park a few weeks back but things have been picking up again. There are currently 8+ dogs running loose in the park. Yesterday an LAPD officer was in the park playground area while dogs were running loose and nothing was said or done. LAPD also drove by at around 7:45pm and there were dogs off-leash and they didn't do the bare minimum and get on their loudspeaker to tell them to leash up. This sends mixed messages to people who come every day that they are allowed to have their dogs off-leash. When there isn't any consistent enforcement and tickets being written things quickly go back to the way they were. Also, this undermines the park staff that has been coming out periodically to tell people to leash up. Working together with a consistent plan is the only thing that will make a change. While the sliding gates were installed - they are only 4-5 openings and we asked for 8-10 openings. If enforcement can't be done the fences need to be removed. As discussed, Oakwood is the only fully enclosed park on the westside.

Also, we were told months ago on two occasions there would be warning letters sent to the people we can identify. Community members shared photos and license plate numbers. Were warnings sent out? My partner was walking our dogs months back and was verbally assaulted by Russell Smith 654 San Juan, Venice, CA 90291. Russell

sent me an email apologizing for yelling at her as he thought it was me. He went on to explain/admit that he brings his dogs to Oakwood unleashed. Mr. Smith was also at the original meeting last year when it was stated by LAPD, Parks & Recs, and Animal Control that people will be cited if their dogs are off-leash.



Thank you for your email. These last few months there has been an issue with the golf course computers not being able to transmit each day's loyalty point information to the central server every night. This is the reason why you see different point totals at the bottom of your receipts that do not add up especially when you play different courses. The problem has not been resolved yet but in the meantime point totals are now updating once a week on Fridays. While point totals are not 100% accurate, what the golf course staff can see is very close. We are working with the vendor that provides our Point of Sale systems to come up with a fix that will allow loyalty points to sync up daily but we do not have a timeline on when that will be yet.

Attached you will find a spreadsheet of all your transactions going back to July of 2018. Your current point total is not negative, you actually have 159 points. Your round from 8/3/21 has not been added to your total yet, so after this Friday your total will be 195. In looking at the spreadsheet you will see the points you have earned, the date, and the course that they were earned at. The numbers in parenthesis are the points you have redeemed and represent a negative number. If you think there is an error for a specific date let me know and I can look into that transaction further.


