RECOMMENDATIONS

1. Approve the submission by the Department of Recreation and Parks (RAP) of a continued funding application to the California Department of Education (CDE) for subsidized preschool services at RAP's two licensed child care providers, Jim Gilliam Child Care Center and Ralph M. Parsons Preschool at Expo Center through the California State Preschool Program (CSPP) and California General Child Care and Development Program (CCTR);
2. Authorize RAP's General Manager or designee to execute two (2) grant agreements (one for the CSPP and the other for the CCTR) in the form substantially as attached to this Report as Attachment 1 and Attachment 3 and accept and receive funds from CDE for Fiscal Year (FY) 2021-2022 with funding in the amount of Five Hundred Sixty-One Thousand, Eight Hundred Eighty-Four Dollars (\$561,884) for the California State Preschool Program (CSPP) for subsidized preschool services at the Jim Gilliam Child Care Center and Ralph M. Parsons Preschool at Expo Center (Agreement No. 2182-CSPP-1174), and Twenty-Five Thousand, Eight Hundred Twenty-Two Dollars (\$25,822) for the California General Child Care and Development Program (CCTR) for services at the Jim Gilliam Child Care Center (Agreement No. 2182-CCTR-1085), (collectively, "Grant

- Funds”), subject to Mayor and City Council approval;
3. Adopt the attached Resolutions for Grant Agreement Nos. 2182-CSPP-1174 and 2182-CCTR-1085 certifying the approval and authorization to enter into these agreements with CDE;
 4. Direct RAP staff to transmit a copy of the aforementioned grant agreement documents to the Mayor, Office of the City Administrative Officer (CAO), Office of the Chief Legislative Analyst (CLA), and to the City Clerk for Committee and City Council approval before accepting and receiving the grant awards, pursuant to Los Angeles Administrative Code Section 14.6 et seq. as may be amended;
 5. Authorize RAP's General Manager or Designee to accept and receive from CDE continued funding of Five Hundred Sixty-One Thousand, Eight Hundred Eighty-Four Dollars (\$561,884) under the FY 2021-2022 CSPP for subsidized preschool services at the Jim Gilliam Child Care Center and Ralph M. Parsons Preschool at Expo Center, and Twenty-Five Thousand, Eight Hundred Twenty-Two Dollars (\$25,822) under the FY 2021-2022 CCTR for the Jim Gilliam Child Care Center, or any subsequent amendments to such funding not to exceed \$25,000 per grant award (in compliance with the Grant Ordinance, Admin. Code Section 14.8(b)(1)A), subject to the approval of the Mayor and City Council;
 6. Designate RAP's General Manager or designee, as the agent to conduct all negotiations, execute and submit all grant documents, including, but not limited to applications, agreements, amendments, and payment requests, which may be necessary for the acceptance and use of Grant Funds;
 7. Authorize RAP's Chief Accounting Employee or designee to establish the necessary accounts and/or to appropriate funding received within "Recreation and Parks Grant" Fund 205 to accept the FY 2021-2022 continued funding from CDE in the amount of Five Hundred Sixty-One Thousand, Eight Hundred Eighty-Four Dollars (\$561,884) for the Jim Gilliam Child Care Center and Ralph M. Parsons Preschool at Expo Center FY 2021-2022 CSPP, and Twenty-Five Thousand, Eight Hundred Twenty-Two Dollars (\$25,822) for the Jim Gilliam Child Care Center FY 2021-2022 CCTR, or any amount awarded in subsequent amendments to such grant awards; and,
 8. Authorize RAP's Chief Accounting Employee, or designee, to make any technical changes, as may be necessary to effectuate the intent of this Report.

SUMMARY

RAP has been receiving funding from CDE for over 34 years to provide child care services at Jim Gilliam Child Care Center, which has a licensed capacity to serve 45 children in a high-need area, and for the last five years at Ralph Parsons Preschool, which has a licensed capacity to serve up to 90 children. CCTR provides funding for subsidized care for children aged two to three years and CSPP provides funding for subsidized care for pre-kindergarteners. These grants assist with serving children of families with incomes at or below seventy-five percent (75%) of the State median income level.

Studies have shown that preschool programming helps children develop academic, cognitive, and behavioral skills that have proven to increase their chances for future success. The full-day services also give participant's parents, who would otherwise be unable to afford these services, the opportunity to seek employment, or return to school in hopes of creating better economic opportunities for their families.

RAP received two grant agreements from CDE to be executed for FY 2021-2022, which will award RAP Five Hundred Sixty-One Thousand, Eight Hundred Eighty-Four Dollars (\$561,884) for CSPP at the Jim Gilliam Child Care Center and Ralph M. Parsons Preschool at Expo Center, and Twenty-Five Thousand, Eight Hundred Twenty-Two Dollars (\$25,822) for CCTR at the Jim Gilliam Child Care Center. These awards are maximum reimbursable amounts with payments made by CDE based on RAP's quarterly reports of actual enrollment, attendance, and expenses. Each of the agreements requires the Board of Recreation and Park Commissioners (Board) to adopt a resolution (attached hereto this Report) as authorization to enter into the agreements.

FISCAL IMPACT

Acceptance of the CSPP and CCTR grants from CDE do not require RAP to provide matching funding; therefore, it would not impact RAP's General Fund. These grant awards provide funding to continue the subsidized preschool programs at the Jim Gilliam Child Care Center and Ralph M. Parsons Preschool within EXPO Center.

CONTRACTOR'S NAME: CITY OF LOS ANGELES-DEPARTMENT OF RECREATION AND PARKS

This Agreement is entered into between the State Agency and the Contractor named above. The Contractor agrees to comply with the terms and conditions of the CURRENT APPLICATION; the GENERAL TERMS AND CONDITIONS (GTC04/2017)*; the CALIFORNIA STATE PRESCHOOL PROGRAM REQUIREMENTS*; the FUNDING TERMS AND CONDITIONS (FT&C)* and any subsequent changes to the FT&C*, which are by this reference made a part of this Agreement. Where the GTC04/2017 conflicts with either the Program Requirements or the FT&C, the Program Requirements or the FT&C will prevail.

Funding of this contract is contingent upon appropriation and availability of sufficient funds. This contract may be terminated immediately by the State if funds are not appropriated or available in amounts sufficient to fund the State's obligations under this contract.

The period of performance for this contract is July 01, 2021 through June 30, 2022. For satisfactory performance of the required services, the contractor shall be reimbursed in accordance with the Determination of Reimbursable Amount Section of the FT&C, at a rate not to exceed \$49.85 per child per day of full-time enrollment and a Maximum Reimbursable Amount (MRA) of \$561,884.00. During the term of this contract, the MRA may be adjusted through an Allocation Letter issued to the Contractor by State Agency.

CONTRACTOR CERTIFICATION CLAUSES

1. STATEMENT OF COMPLIANCE: Contractor has, unless exempted, complied with the nondiscrimination program requirements. (Gov. Code §12990 (a-f) and CCR, Title 2, Section 11102) (Not applicable to public entities.)

2. DRUG-FREE WORKPLACE REQUIREMENTS: Contractor will comply with the requirements of the Drug-Free Workplace Act of 1990 and will provide a drug-free workplace by taking the following actions:

a. Publish a statement notifying employees that unlawful manufacture, distribution, dispensation, possession or use of a controlled substance is prohibited and specifying actions to be taken against employees for violations.

All Contractors contracting for the procurement or laundering of apparel, garments or corresponding accessories, or the procurement of equipment, materials, or supplies, other than procurement related to a public works contract, declare under penalty of perjury that no apparel, garments or corresponding accessories, equipment, materials, or supplies furnished to the state pursuant to the contract have been laundered or produced in whole or in part by sweatshop labor, forced labor, convict labor, indentured labor under penal sanction, abusive forms of child labor or exploitation of children in sweatshop labor, or with the benefit of sweatshop labor, forced labor, convict labor, indentured labor under penal sanction, abusive forms of child labor or exploitation of children in sweatshop labor. If Contractor violates any provisions of above paragraphs, such action by Contractor shall render this Agreement void. (Pub. Contract Code §10420)

Members of boards and commissions are exempt from this section if they do not receive payment other than payment of each meeting of the board or commission, payment for preparatory time and payment for per diem. (Pub. Contract Code §10430 (e))

2. LABOR CODE/WORKERS' COMPENSATION: Contractor needs to be aware of the provisions which require every employer to be insured against liability for Worker's Compensation or to undertake self-insurance in accordance with the provisions, and

Contractor affirms to comply with such provisions before commencing the performance of the work of this Agreement. (Labor Code Section 3700)

3. AMERICANS WITH DISABILITIES ACT: Contractor assures the State that it complies with the Americans with Disabilities Act (ADA) of 1990, which prohibits discrimination on the basis of disability, as well as all applicable regulations and guidelines issued pursuant to the ADA. (42 U.S.C. 12101 et seq.)

4. CONTRACTOR NAME CHANGE: An amendment is required to change the Contractor's name as listed on this Agreement. Upon receipt of legal documentation of the name change the State will process the amendment. Payment of invoices presented with a new name cannot be paid prior to approval of said amendment.

5. CORPORATE QUALIFICATIONS TO DO BUSINESS IN CALIFORNIA:

a. When agreements are to be performed in the state by corporations, the contracting agencies will be verifying that the contractor is currently qualified to do business in California in order to ensure that all obligations due to the state are fulfilled.

b. "Doing business" is defined in R&TC Section 23101 as actively engaging in any transaction for the purpose of financial or pecuniary gain or profit. Although there are some statutory exceptions to taxation, rarely will a corporate contractor performing within the state not be subject to the franchise tax.

c. Both domestic and foreign corporations (those incorporated outside of California) must be in good standing in order to be qualified to do business in California. Agencies will determine whether a corporation is in good standing by calling the Office of the Secretary of State.
