Thank you so much for the meeting today on the pony rides. While I didn't get a chance to speak, I appreciate the thoughtful discourse. I watched a YouTube video of a girl falling from a pony and being dragged and trampled taken last year (one speaker mentioned it). Fundamentally, this issue wouldn't be addressed by the changes recommended by the veterinarian. Furthermore, rather basic health issues seemed to be ignored until the announced visit by the vet.

There's a pretty clear pattern of neglect and I'll-only-fix-what-I-have-to-when-I-have-to from the concessionaire while allowing risk to the public and these ponies.

I'd strongly urge the commissioners not to renew the contract and to replace this outdated and dangerous sideshow with a safer, more wholesome, and more empathetic feature. Griffith Park is a world-class park, and LA is better for it, but this pony ride gives it a black eye.

Please do the kind thing and help these ponies retire to a sanctuary.

I listened in to today's meeting about the pony rides at Griffith Park and I strongly feel that the contract for this venue should not be renewed. There is clearly a history of neglect here that has gone on for years, and while there have been adjustments made since there's been more attention brought to the issue, that is not guarantee that conditions will continue to be met. This is especially true considering the high cost of maintaining adequate conditions.

And even so, we should not be teaching the children of Los Angeles that animals exist merely for their entertainment. These are living beings who surely do not want to slave away all day, walking in circles endlessly, with children on their backs. Just because they can't speak our language to tell us they don't like it, doesn't mean we should continue to subject them to it.

There are much better ways to educate children about animals, like allowing them to respectfully interact with them in sanctuary settings (reputable sanctuaries like The Gentle Barn for an example).

Surely, a creative city such as Los Angeles can come up with a better, non-animal activity for children instead of this outdated ride.

Dear Commissioners:

In 2008, I made a documentary film called BLINDERS about the use of horses in an urban setting. While making the film, I interviewed equine experts who, on behalf of the ASPCA, studied and monitored the horses who pull carriages in Central Park. While pony rides and horse-drawn carriage rides are not the same, some of the conditions that make these concessions inhumane are.

Horses are grazing animals, but, in Griffith Park, they don't have access to a grassy pasture for daily turnout. That's inhumane. Also, horses are prey animals, not predators. When they spook and bolt, they become unwitting weapons. People who operate horse concessions in urban areas claim that their horses are bomb proof, but we've seen these horses get spooked by sirens and unfamiliar objects. No amount of regulation or enforcement can stop a horse from spooking.

In recent years, the mainstream public has become more and more disturbed by the use of animals for our entertainment. That's why Ringling Bros. eliminated animal acts and why Seaworld is no longer breeding killer whales in captivity. When animals are commodified, cruelty is built into the business model. The owner of the pony ride concession simply cannot make a profit if he provides the nearly 50 horses in his possession with sufficient veterinary care, farrier care and dental care. Selling a sick or injured horse to a killer buyer and buying a new one with the proceeds is far less expensive.

Making money off the backs of horses is outdated and cruel. That is why progressive lawmakers should help the owner of this concession transition to cruelty-free forms of entertainment. What about hay rides and potato sack races? The options are endless.

It's 2022, we have to do better.

PLUS All Funbox locations support a small, localized community that advocates and supports children in foster care.

I urge you to look into this possibility. Please end this & make sure these animals are sent to a sanctuary.

Hello,

My name is Jessica Booher. I am urging you to (1) not renew the contract with Griffiths Park and (2) outrightly ban all pony rides in LA.

In addition to what others have commented today, I also wanted to note that most of the ponies' halters are ill-fitted, putting pressure on the delicate nasal bone. This is especially concerning given that so many of the ponies are seniors, who should have been retired long ago regardless of how much they allegedly "love" their work. This is also unsafe for children, as the lack of a helmet requirement poses a serious risk to riders. Even people with minimal equine experience are aware of this, and even some of the most experienced equestrians in the world such as Olympic riders wear helmets every time they sit atop a horse.

Publicly, on Griffiths website, there are multiple pictures of ponies with pinned ears, indicating anger, discomfort, or both. Additionally, you can quickly and easily find many photos and videos of workers clapping and running behind the ponies, with the intent of scaring them into work they obviously do not want to perform. This strongly undermines Griffiths Park's claims about how much their ponies "love" their work.

Any person who loves and/or is familiar with horses is appalled by the existence of such pony rides, regardless of how well Griffith Park claims to treat the animals under their care. Seeing ponies being treated as objects forced to do labor does NOT foster respect or a love for animals. I hope these ponies are all put out to pasture as soon as possible. Please do not renew the contract.

Dear Honorable Council members,

Stephen Weeks, comparing wild horses to ponies, shows limited knowledge or concern for these ponies ! There is no comparison. Wild Horses know how to care for themselves in the wild. These ponies are caged and rely on humans to care for them !

Some of the ponies are fat, most likely due to once a day feeding, causing them to over eat at feeding time or he doesn't feed enough and some ponies eat more than others. Laminitis, an extremely painful condition, affecting the laminae tissue connecting the hoof wall to the pedal bone, can be the result of this overweight condition!

Walking a pony w laminitis will cause more damage to the hoof and is clearly evident in several of these ponies. He treats them as if they were in a slaughterhouse, sucking every bit of life out of them knowing he can get another one.

They show signs of depression!
The level-neck "withdrawn" stance, dull stare, immobile head and ears, and reduced reactions to humans yet increased reactiveness to new stimuli,such as when that guy was forcing them to run.

A daily minimum of 45 minutes should be spent grooming and assessing/documenting each pony's health initialized by another caregiver, accountable for their approval. Feed and drinking water should be available twice daily including adequate fodder and concentrates with a high content of nutritional substances. These ponies spend day after day working in the hot sun w/ no available water.

Reasonable Provisions for ponies:

1. Provide a pasture while mucking out the pony enclosure !Ammonia from urine and manure is harmful to horses, causing problems like thrush, a fungal yeast infection that can grow in the mouth, throat and other parts of the body and damage to their hooves !
2. Provide clean comfortable bedding.
They prefer to be strongly rubbed and stroked on the neck, shoulders, hip and chest. Some ponies enjoy having their heads and ears rubbed. Their muscles get tight and sore just like ours do.
3. Do a visual check for any scrapes, cuts, bruises and puncture wounds on the ponies legs, head, and body. Treat any injuries promptly and have a horse first aid kit on hand.
4. Daily care and bonding
Do a visual check, while grooming to rid them of the dirt/dust/lose hair and for signs of illness and injury Daily hoof cleaning, ck for any problems w their feet for any bruising, cracks, or loose shoes.

Ponies like to be spoken to in a calm, generally low-pitched, and natural voice while being cared for.

These ponies are barely alive due to the excruciating poor care.
Please don't support this animal abuse and neglect ?

I would appreciate a return email with your thoughts.

Hello and THANK YOU for your fair and balanced inquiry into the activists' concerns at the Griffith Park Pony rides.

As a horse owner myself, I listened to the council meeting with keen interest. I was relieved to hear you ask fair questions, and that you worked to help all understand that the findings of the independent auditors were not egregious, in fact were largely in the realm of record keeping and that many of their concerns have already been addressed.

I was not called upon to comment, but it was with absolute shock then during public comment that I listened to the well intentioned, but unhinged comments, from very organized activists who clearly have had no personal experience with horses.

As you come to making a decision, I urge you to take into consideration that the optics of animal keeping of all kinds will feel foreign to those who do not have access to animals. Without access there is no understanding. We absolutely need to work together as an equine community to keep this vital resource for the purposes of access and education. We need to work together to improve the optics by increasing understanding/educating the public.

There are very real places of concern for me with horse keeping, primarily with hoarders masquerading as sanctuaries that don't have the resources to care for the animals they have. THAT is where you see gross neglect. The ponies in Griffith Park are clearly well fed, are relaxed and happy, and enjoy their job. Trust me, if they didn't they would be behaving very differently!

As I'm sure equestrians have shared, a happy horse is one that has a relaxed head carriage, is breathing normally, and is calm. The only distress I encountered when visiting was that of parents of small children struggling to wait in the long line.

It is with distinct fondness that I recall bringing friends to the pony rides for my daughter's birthday party. It was before we had horses of our own, and it was the moment that made my daughter fall in love with horses and set us on the road to finding an area where horsekeeping is possible (the amazing Lake View Terrace!)

Please consider taking actions to preserve this incredible resource for access for those who do not have a lot of money. If you consider changes, please work to increase the public's understanding of horses and add an education element to the experience. It's only really the optics that need to change.

As Campaigns Director for In Defense of Animals, a California-based international animal protection nonprofit organization with 250,000 supporters, I'd like to share our concerns that Griffith Park and Pony Ride does not meet the basic standards of care for equines.

Many of our local supporters have reported that these ponies haven't received proper dental care and have been working with saddle sores. We received reports of animal abuse and neglect, including a pony with gait issues who was allowed to perform rides. The ponies at Griffith Park appear to be languishing in the heat and cold, and suffering from depression.

We urge you NOT to renew the contract for Griffith Park and Pony Ride, to send these ponies to a sanctuary, and to offer non-animal entertainment at this park to demonstrate compassion for animals.

As a former horse owner myself, I join those who have said the treatment of the ponies at the Griffith Park pony rides is concerning. It is upsetting to see these ponies tethered to a live carousel made to walk in circles, or to spend hours each day no matter the weather going around and around the pony rides ring. There's also a private party area in which one pony is forced to give rides to the children attending the party. This is a difficult thing to witness and no life for these animals. This is not the way to teach children to interact with or enjoy animals.

There is a considerable smell in this area. The ponies are kept outside in the heat. Are they getting watered frequently enough? What about rest periods? I have seen disturbing videos which have shown potentially dangerous situations for the children riding these ponies. I've also heard there are third party equine veterinarian findings that indicate the ponies haven't received proper dental care and are suffering saddle sores, meaning they are made to work in discomfort of pain. Why the necessity for observers to report these situations before change is made rather than the concession owners doing right by these living beings who are forced to work for a living?

Los Angeles has moved in the direction of becoming a more animal friendly, kind city which has banned the declawing of cats, banned fur sales, banned the usage of wild animals for entertainment. It is devastating to see the sad ponies who are forced to give countless rides. It is no different from an animal having to work in a circus.

I hope Los Angeles remains a forward thinking city with regard to animal welfare and encourages compassion and kindness towards animals. Banning the pony rides would be a huge step forward in teaching children empathy toward all living beings. Please do not renew the contract for these pony rides at Griffith Park. We urge you to replace these pony rides with non-animal, fun attractions such as trains to ensure that parents can take their children to Griffith Park for safe, fun

rides that do not exploit any animals. These animals deserve to be sent to a sanctuary to live of the remainder of their lives of service in peace.

I have consistently ridden horses since I was ten years old (I am now in my mid-40's). The first picture of me riding was from when I was about 2, and it was on a pony ride similar to the Griffith Park Pony Rides setup. Since my first introduction to horses, I was that "horse-crazy kid" that would do anything to ride.

Horses (and ponies) helped me through depression and anxiety as a child and through my teens. I was so painfully shy that I couldn't look at people, let alone speak to strangers. Being around horses, taking on responsibilities for their care, exercise, and working with other people at the barn - kids and adults - helped me become more confident and allowed me to overcome the anxiety I felt on a daily basis.

Neither of my parents were "horse people." Without pony rides, there's a very good chance that I would have never been introduced to horses. Organizations like Griffith Park Pony Rides and other horse rental stables in Los Angeles provide access to city kids who wouldn't be introduced to horses every day.

Working with these amazing animals, both as an owner/rider and as a vet assistant for an equine veterinarian, has given my life stability when everything else seemed to fall apart. Riding kept a lot of us sane throughout the pandemic because we were able to keep riding since its an outdoor activity. The people I know in the horse world will do anything to provide for their equine companions. We give up vacations, and spend countless hours happily caring for and working with our 1,000 pound kids.

Steve Weeks is a good man, a good business owner, and cares for the horses (ponies) in his program. He has gone beyond what is required to care for them when they become sick, even sending them to the hospital on more than one occasion. I know this because I have been called out a few times to trailer a pony to West Coast Equine Hospital in Somis. The staff that I interacted with was always knowledgeable, friendly, and genuinely concerned about the health of the pony I was picking up. They had already called their local vet for care, and when the pony didn't improve with routine medication they didn't hesitate to take the next step of hospitalization.

While there is always room to improve in any situation, the ponies in question are not being over worked or suffering from poor care. The people making these claims appear to have little to no knowledge of livestock care requirements, and have a blanket thought process when it comes to animals in general being used by humans. They think it's cruel. There seems to be no thought on their part of the amount of work we put in as guardians of the animal in question, and no effort on their part to learn about the animal or it's abilities. If they would spend time with the actual animals in question, rather than make judgments from afar, maybe they would realize how much horses and humans improve each others lives.

Please don't shut down the Griffith Park Pony Rides. Ask for the concerns brought up by Dr. Sacher to be addressed, that's reasonable. But the pony rides should remain - for the good of the ponies as much as the people of Los Angeles.

For many years I have driven past those pony rides on my way to the barn where I keep my horse. I have wondered about them getting enough rest and water on hot days, and I have walked down there to see for myself.

However I have seen a marked improvement in their welfare since Mr Weeks has taken over. There are some things which could still be attended to. But looking at the general age of the animals they would not have reached those ages if they hadn't been adequately cared for. Older animals do have more dental issues, and so that is expected to be an area of concern. However if their teeth were a bigger problem, they would not be able to eat properly and their general condition would reflect a loss of weight.

The other conditions are easily fixed and I would expect that Mr Weeks will be able to deal with the other issues quickly. I have heard that the protest group complained that the ponies didn't have their heads raised. I would note that the preferred posture of a horse or pony is with it's head down. When they raise their heads it is to deal with an alarming situation. In nature they raise their heads high to get a better look at a perceived threat. We enjoy seeing their heads up because they look so beautiful when alert. But for a horse or pony, that is not a relaxed position to maintain. If the public understood the stance, no one would want to put their child on a pony ready to flee the area.

I thank the concerned groups who have brought these conditions to your attention, but I deplore they actions in creating anxious visits to the children's recreation area. I hope that they will now go away and find a more worthy subject for their inspections. Lord knows there are many things they could be attending to. Dogs chained in yards with no water might be a suitable target.

I support the children's pony ride operation, and the joy they bring to generations of LA's children. With the additional veterinary attention and watering requirements I would expect an increase in the cost of a ride. Please know that children have very little access to the natural world, and removing this outdoor activity would further reduce the childhood experience that is in so much short supply.

Dear Mr. Rudnick and colleagues:

As a horse owner who previously boarded my ranch quarter horse at Griffith Park and who still pays for and holds two city licenses for my horses, including my rescued mustang, I must chime in on the insanity you are dealing with right now.

It is sad that we are living in the age of 'emotional instigation' and trolling, and this so-called animal rights group is among the strident people who, in fact, often actually hate horses and are on a mission to get them out of city locations. Are they a cover group for real estate developers? You decide, but as a former Adjunct Professor at Cal Poly Pomona who worked with the City's LA River Revitalization Program for many years, I saw a fabulous watershed-based urban nature program degenerate into a 'developer pay for play' scenario and I sense this is at least subtly at play here, especially in light of the City constantly seeking new revenue sources within Griffith Park a la LA Zoo expansion, often in direct conflict with the Griffith covenants in the original grant deed.

Because, in truth, why get rid of pony rides, rodeo and other western heritage events at the Equestrian Center and adjacent properties but for the goal of making \$\$\$\$\$\$\$\$\$\$ and destroying what's left of the Los Angeles I moved to and came to love over 40 years ago? Tom LeBonge, Walt Disney and Gene Autry must be rolling over in their graves, as is the Griffith family, to see the continued commercialization and real estate development in Griffith Park at the expense of its traditions and outdoor activities for 'the common people of Los Angeles'.

Speaking specifically to these urban terrorists known as The Los Angeles Alliance for Animals, I've learned over the years that these organizations are fully of well-meaning but traumatized individuals who bring their personal anxiety to social causes with no care about what the actual facts of the situation are. This includes the BLM Mustang Round-up and Adoption Program, too. If these people really cared about equine safety and health, they would be financially supporting and assisting in direct horse care and husbandry, not protesting about perceived harms. You are likely too young to remember the days when backyard barns with horses were common in the San Fernando Valley, but I do. Now we are two generations into urbanization where today's children are learning nothing about what horses teach us since we have decided to 'segregate' them away from humans. And to think that the horse built this city during the early years through its labor and then built the juggernaut of Hollywood through a 30 year cycle of popular movie and television Westerns, always featuring horses and often including singing cowboys. This is a tremendous loss because the horse teaches humans more about emotional and intuitive intelligence than any other animals. And the pony is usually the 'gateway' to this connection.

Instead of the City and social groups looking to return the horse to its right place as an urban partner, we now deal with misguided protestors who have chosen to terrorize already stressed out families who want to spend time with their children/grandchildren in an outdoor environment where they can love and interact with ANIMALS AND HORSES THAT CANNOT GIVE YOU COVID!!!!

In fact, in the first year of covid when my buckskin was still boarded at the Rancho, I offered free 'horse hugs' for numerous first responders, medical staff, clergy and others dealing with the first wave of the challenges of this 'plague'. Everyone needs hugs right now and horses are the best huggers! Ponies are also the best lovers/huggers for little people. :)

I also want to respond directly to the health and safety issues raised by this misguided group with the full disclosure that 1) I know no one in the LA Alliance and 2) I do not personally know any of the owners/managers/employees of the current pony ride operator.

First of all, I will state for the record that I was very critical of the previous pony ride operator and was glad to see them go since, at that time, I observed clear animal neglect on their part.

Secondly, when this current 'blow-up' started to get traction, I made my own private, unannounced walk-around to the Griffith Park Pony Rides and here is what I saw:

1. Ponies who appeared to be older - 10 to 20 years old - well groomed and healthy but obviously shaggy looking because of their heavy winter coats. Shaggy winter coats have nothing to do with bad health or neglect.
2. Clean repaired, albeit older, tack on all the equines.
3. A very clean and well-organized concession entry/safety waiting area with friendly staff.
4. A 'calm energy' and adults and children of all ages petting (see covid note above) and enjoying the pony rides, including the little tractor pull ride.

I've read both the veterinarian's report and your task force's recommendation and, while, I think you are trying to 'be Solomon' here, you are placing an added and, in my opinion, unnecessary burden on the current pony ride operator to take on additional expense to do these 'enhancement' corrections with 60-90 days. How about the City paying for these 'recommendations' since the neutral veterinarian clearly indicated that the ponies were clearly fine and in good health? That way you can appease both the animal rights people yet support a ride operator who has done the City and Griffith Park a great service by returning a quality pony ride operation to the City.

A couple side notes:

A. 'The Ponies were outside in the rain' complaint. Really? That's what they do! They live in nature!!! Yes, we had unusual rainfall for a couple weeks and EVERY horse area in Los Angeles, including the ranch where I currently have my two horses, was flooded and sloppy. But the horses and ponies were fine. I fail to see why trying to create 'human' conditions, as opposed to 'humane' conditions for animals who have lived outside in nature for over 63 million years, achieves anything.

B. 'The pony with the weepy eye photo'. Haha. I am wiping my horses' eyes just about every day! If it is dusty or windy, they blink to keep moisture in their eyes and sometimes create too much, which leads to the 'weeping' look.

In sum, while I deeply appreciate the challenges you face, I implore you to use some common sense and stop harassing a small business owner who is working hard to bring love, recreation, and the spirit of the equine to suffering Angeleno families during these interesting times, and I encourage you to explore enacting a City regulation on equine liability and related liability insurance rules similar to the one that the State of Hawaii has long used to protect equine recreational organizations from crazy liability insurance premiums and nuisance suits that have bankrupted at least 3 very fine trail riding operations I know of in Los Angeles County within the past 7 years. I carry my own equine liability insurance since I use my horses in equine assisted experiential learning coaching, so I personally know what a burden this element of equine business requirements is.

Thank you for your patience in reading this rather long note to you. I am available for any private conversations/consultations at no cost if it would be helpful to your efforts to find a positive, productive balanced solution to this challenging situation.

And...my horses remain available for private no-cost 'hugs' as long as you are willing to trek out to Los Angeles' Hansen Dam area to visit them.

When I was a little girl, **my dad took me to a pony ride and it changed my life!** I fell in love with horses. I started drawing horses and eventually went on to become a professional artist. Despite the fact that my parents didn't have a lot of money, they gave me a pony for my 11th birthday. My pony was my best friend well into adulthood. Being around horses, caring for them, loving them, has given my life profound meaning and joy -- all because my dad took me to a pony ride!

The Los Angeles Alliance for Animals is a small group of activists, with radical viewpoints, who know nothing about horses. They only have 108 followers on Twitter. Their bio reads: **LAAA is an all volunteer, grassroots group formed to end exploitative pony and horse rides in the LA area.**

There is nothing exploitive about pony rides. Pony rides are a wonderful way for people of all backgrounds to spend time with horses.

I am writing to express my opposition to the LAAA and their issues with the Griffith Park Pony Rides. As a business, the people who operate the pony rides are subject to oversight and have the animals' best interests at heart. The ponies receive regular shoeing, nutrition and vet care and most importantly love from all their carers and the children who visit. The LAAA may think they are well intentioned but most of them don't know anything about horses and are misguided, and they don't realize what a valuable service the pony rides provide to small children.

My first equine experience at eight years old was a donkey ride at the beach, followed by pony rides at the zoo, then on to working part time at a riding stable in exchange for a lesson or a trail ride. I eventually bought my first horse at the age of 20 and have enjoyed being a horse owner ever since. In addition to being a safe and healthy lifestyle, horse ownership has a trickle down effect on the local economy in Sunland: Because I work full time, I keep my horse at a boarding facility 18 miles from where I live where staff are employed to take care of the horses, I pay a trainer to work with my horse, I buy feed & shavings from the local feed store, I buy tack & clothing from other stores, and I pay a shoer, a vet, and an equine chiropractor to keep my horse in the best health and condition possible. I say this not to impress you but to drive home the point that it all started with a donkey ride. Take away the pony rides and you take away the dreams of a pony mad child whose parents may not be able to afford riding lessons.

Most horse owners are like me and don't want to see our way of life being outlawed by a group of woke people because it's the latest trendy bandwagon to jump on. Hello, I'm Lucas, an equine professional who has been caring for, managing, and teaching humans and horses for 15 years. I am writing today in response to backlash I've seen toward the Griffiths Park pony rides. As a professional in my field I find it very important to keep up with the latest research in animal behavior and ensuring the comfort of my animals. Based on what I have seen of the pony ride program, they are doing a good job of providing for the mental and physical wellbeing of the animals. Many of the arguments I see in opposition are labeling animal behaviors as if they were human behaviors. This however is both factually incorrect and potentially harmful to the wellbeing of the animals. Naturally horses are nomadic grazing animals who live in open grasslands and are prey to carnivores like big cats or bears. Horses who may appear "sad" to those who don't understand horse behavior are actually relaxed, which is a positive expression for a prey animal as high alertness indicates stress and expectancy of danger. As for the horses not at work seen standing in the rain, even with free shelter access, many horses choose to stand in the elements. As I stated before horses are adapted to live in open grasslands where shelter from rain is not frequently available, therefore it's natural that the horses wouldn't mind the rain. In fact study after study has indicated that horses benefit exceptionally from living outside rather than in a barn. Horses stuck inside for extended periods of time can suffer from a long list of health issues such as gastric ulcers, colic, and upper airway irritation as well as adopt vices in response to the mental stress of not being able to move freely.

In addition to not seeing any merit in the critique of the care of the animals, I believe that keeping the program is important to the wellbeing of youth in LA as well. In my years of experience I've been able to work with many different types of programs from large show facilities housing valuable horses for use in the show ring to small suburban facilities to provide riding lessons to kids and adults with disabilities. In this I have seen what a positive impact contact with horses has had with people. Horses are heavily social creatures and are very receptive to our emotions. For so many people the horses become their safety and getaway from the stressors in their life. That first pony ride for a child may very well be what keeps them out of gangs and off of drugs, as crazy as that may sound. For many horsemen, that first pony ride is what inspired them to start. I can attest from my own life experiences that horses draw people in like nothing else. As a direct result of being drawn to horses myself and many other youths found a sense of belonging and a place to learn responsibility, and emotional stability. This is not me talking about my experiences in a vacuum either, there is research which confirms the benefits of human-equine interaction. This is why therapeutic riding centers have popped up all around the world. This is why groups like the Compton Cowboys are able to make positive impacts in their communities. Furthermore, if there is any concern that therapeutic interactions between horses and humans are less than therapeutic for the animals, I can confirm as someone who assisted in a study conducted by Tufts looking into this very question that the animals are experiencing no stress from interacting with humans.

I really hope you consider all of this in regards to the pony ride program.

It has come to my attention that there are a small group of activists that have focused their attention on the local pony rides at Griffith Park. Over the weekend, I took a trip over to look at the operations in the park myself. I have been around equines since childhood and the facility and the behaviors of the ponies and staff at the concession looked clean, responsible and cared for. I even took a ride on the little train so I could view the backstage areas of the pony rides, where the animals are housed.

I have reviewed the reports and the responses from Mr. Weeks regarding the implementation of all the recommendations by the inspecting veterinarians. I feel that Mr. Weeks is conscientious and responsible in his care of these animals and the facility at which they are housed and exercised. As someone with a background in equine care, this is the most important thing to consider, the physical well being of the animals. Someone who is not actively involved with equine care, is not a responsible party to determine these animals' well being. Those who have heightened emotions about domesticated animals, may not have the important experience to adequately evaluate the operation and the well being of the animals.

During my visit I also noticed the families that were at the facility, the diversity of our local community was reflected in those waiting to participate in this healthy outdoor activity with their children. In this era of restrictions, these healthy activities are even more important for the well being of the children of our community. Many will only have this opportunity to experience the joy of riding a pony and these memories will last a lifetime. In some cases, it will inspire a lifetime of healthy and positive interactions with equines in many different ways. The financial accessibility of the pony rides is an important aspect of the concession remaining open for our community members at all financial levels.

Kids hanging out at the barn learn responsibility, dedication, and how to put an animals needs before their own. I cannot tell you how many have gone on to serve in noble careers such as nurses, teachers, veterinarians, even a Los Angeles Superior Court Judge. These are traits our youth desperately need in today's world, and yes it can, and has, started from a single pony ride.

We know that the activists coming after the pony rides are using it as a tool, a tool to make extinct the relationship between man and horse. They are going after our western lifestyle, a lifestyle that built Los Angeles. A lifestyle of integrity and empathy and love for our animals. I have taken nieces and nephews to the pony rides and I am always aware of the care and condition of the ponies. I would not support them if I noticed that they were abused in any fashion. In fact the conditions there have improved over the past several years. The Griffith Park Pony rides are an institution, an institution that we need to support and encourage not eliminate. The animal activist have a much broader agenda than the condition of this one business. Please see past them and do not be fooled by the nonsense they are trying to push on us.

Hello there!

I am a follower of some western content creators on social media, and I recently saw some distressing news regarding your consideration to ban/end pony rides at Griffith Park and other western equestrian sports in the city of L.A.

I would like to take a few moments to explain some reasons why you should reconsider that decision, and why these are acceptable and even beneficial to the community.

Firstly, the wellbeing of the animals. The ponies are monitored and regulated by multiple state and city agencies as well as by veterinarians. They are all trained using a rewards-based training system, and only verbal encouragement is allowed. The ponies are given regular breaks, always have clean, fresh water available, plenty of shade, water misters, and rubber mats to stand on. They have regular days off, and are checked and monitored daily by staff members. If for some reason the pony does not seem happy or no longer wants to willingly participate, they are rehomed to reputable, vetted homes. They are fed a variety of species-appropriate forage as well as health supplements to keep them happy and healthy. They have free choice of shelter during inclement weather, and if they're more sensitive to the weather conditions, are brought into the barn to stay dry and warm. Many of these ponies were rescued from auctions or less desirable homes, and are now being given the chance to have a happy and productive life with other ponies.

Secondly, the community benefit. If you were not raised around horses, having exposure to them at pony rides can help develop a love for them, and can lead to joining an active outdoor sport. Ponies are also used for therapeutic riding (hippotherapy) for special needs children. The movement of the pony's back during riding is similar to the movement of the human pelvis and can provide muscle relaxation for children with muscle spasms due to medical conditions.

Overall, the Griffith Park Pony Rides are a community staple, and an incredibly beneficial one at that. Closing them would be an absolute shame and a loss for both the city itself as well as the entire community, equestrian or otherwise. We are begging you to please reconsider any decisions you may have to shut them down.



Dear City Officials,

I have lived in Hollywoodland for almost 45 years, and the traffic conditions I saw this past Sunday, January 23, were some of the worst I have ever seen. This was an ordinary weekend.

It is becoming clearer and clearer that the ever growing number of visitors in this very high fire severity zone is way past being unsustainable and now involves negligence by the City of Los Angeles. The regular weekdays of today are much worse than the weekends of the past, and the regular weekends of today are for worse than the busiest holidays in the past.

These are just some of the things I experienced.

I drove up Ledge wood to the illegal view site on Lake Hollywood Drive. On winding narrow Mulholland Highway (just 19 feet wide) past Durand Drive there were at least a dozen pedestrians in five different groups that were walking IN the street and ignoring the no pedestrian signs on both ends of this section of the street. It was particularly harrowing driving because the setting sun was blinding as I tried to avoid hitting someone. Also most of the tarp is now missing from the fence, so the views are all exposed. As I proceeded to go down the hill and past Lake Hollywood Park and then turn around to go back up the hill, I had to **stop five times** waiting for cars to park. The park was filled with people and approximately a hundred cars were parked in this area. The illegal vista had approximately eighty people on it. I have never seen it so busy. I was able to count the people because my car was in a line **stopped for almost four minutes!** That is a very long time. Cars had parked everywhere--including at all of the red curbs and a road leading to a house. One car was not only in the red in front of a fire hydrant, but was sticking out into the intersection blocking one whole lane of traffic at the intersection of Mulholland Highway and Lake Hollywood Drive. There was total gridlock. Needless to say there was no enforcement anywhere. The area looked like a concert or an event had just concluded, with people and cars everywhere, but there was no event that was ending, so I imagine this was the continual state of this location. It is chaos. How many other attractions in Griffith Park have a parking lot for a hundred cars? Are they by standard size roads? I'm sure these locations passed written scrutiny, hearings and a possible EIR. None of that was done here. That is why it is not only illegal, but worse it is dangerous.

After the car which had blocked the intersection moved I was able to turn onto Mulholland Highway. I drove about 50 yards when I had to stop again. A car was stopped/parked in the middle of this very narrow street (19 feet wide) and was signally cars to go around it into a blind curve with opposing traffic. I would not do that, and he refused to move. **I waited for 3 minutes!!** Then I saw a woman sliding done the hill on the private property side of the road. I recognized her from seeing her trespassing on another part of the hill I had just passed. She got into the car which finally began to move. Again, no enforcement anywhere.

I then decided to drive to the top of Deronda. I could get to the end, but passed several illegally parked cars and there was no opposing traffic as I drove. By Mt Lee Road, I did see a City employee--finally--the first City

rep I had seen all day. When I commented about the visitors but had not yet given him any of the details I had just experienced, he volunteered **how overrun this area is, how stretched thin supervision is, how congested it is, how any kind of evacuation would be impossible, how unbelievable the chaos is, and how really dangerous conditions are. This he repeated several times.** I then got back into my car, turned around, and hoped to make it down the hill. I did not get very far. Cars were coming up in the opposite direction, and the legal and illegally parked cars had eliminated two way traffic. The uphill traffic has the right of way. One of the illegally parked cars was an Uber, but the driver would not move. **So I had to back up 5 car lengths on a very narrow street.** (I do not have a back up camera) After I did this the uphill cars were able to go. I then left, but there is a dead end about ten cars up from where they were. They would have to then turn around and deal with opposing traffic, if it came, as I did.

To drive these areas in our neighborhood would normally take just a few minutes. This took a better part of an hour.

Over 40 million tourists annually come to Los Angeles. Seeing the Hollywood Sign is unbelievably at the top of the list of a large majority. There are also local hikers and visitors added to this. They cannot helicopter to the Sign. The thousands of daily cars must use our one hundred year old substandard winding streets where each parked car prevents two way traffic. Our infrastructure just manages to safely cover the needs of residents. It is totally inadequate and inappropriate for tourism. You could not pick a worse place for tourism. A lot of traffic gridlocks Hollywoodland, but honestly so does a little. There are dead ends with no turnarounds at the end of very narrow streets. At many points, a few or even a single car can cause total gridlock.

This brings us to **CAPACITY.** This concept is used universally when it comes to interior public spaces and fire safety. I am sure it is also used in planning when it comes to open spaces, particularly in very high fire areas. The eastern side of Griffith park which has all of the institutionalized public attractions has been closed on occasion because crowds are too large. Our neighborhood with no infrastructure is never closed. **We want to know what the City feels is the proper and safe capacity for visitors at the magnets and in the rest of Hollywoodland,** and what criteria is being used to close down the eastern side of the park and why are they not being used on the western side. In addition to our having no infrastructure, and whenever the eastern side is closed more visitors then come to our neighborhood, how can you possibly ever close down the eastern side of the park without closing our side. There are no legal entrances into Griffith Park from Hollywoodland. Yet we are horribly impacted by bootlegged, and illegal tourist magnets that the City refuses to shut down. You have literally turned our limited hillside community with extremely substandard infrastructure, and very limited ingress and egress that sits as a bottleneck into Griffith park, 80% surrounded by dry brush, into an over 500 acre unsupervised amusement park. This would never be approved in the private sector, and if it did exist, it would be shut down in a matter of minutes. You are the ones charged with public safety. How do you not only allow these conditions, but you're responsible for creating and promoting them? **A minimum of one dozen officials is needed full time to supervise this mess.** This will not solve the problem, but it would help. You cannot successfully shove a square peg into a round hole.

The real solution is that dangerous tourism must be removed from Hollywoodland.

My big regret as I drove around my neighborhood was that I was not accompanied by a local news reporter. That is something I intend to remedy.

I want this letter to be part of the public record. When and not if tragedy comes to Hollywoodland, you and other City reps cannot plead ignorance.

As an unhoused person in LA, it has come to my attention that some massive human displacements have been occurring in LA CITY PARKS and I encourage you to please consider the original purposes & grants that were made when the City obtained these lands, as well as who they were taken FROM, and at the very least consider not exempting anything requiring human DISPLACEMENT from submitting a complete EIR, when conspiring to banish unhoused people from public with nowhere to go, as you have now done or are attempting to do at Echo Park Lake, Griffith Park, Elysian Park (home of the HISTORIC PORTOLA CAMPSITE, former location of an 81-site campground for car & tent camping, & which is currently being considered for LAMC 41.18 designation in an agenda item that was delayed by City Council when it was heard last week. Please, don't let them pass it.) Westchester, Penmar, Ocean Front Walk, MacArthur Park, Alexandria Park, Valley Plaza, Mar Vista Rec Center DURING A PANDEMIC IN WHICH THE HOUSED PEOPLE REQUESTING THESE DISPLACEMENTS ARE PROTECTED BY AN EVICTION MORATORIUM.

The state of emergency (that we are still in) because of a pandemic that is still killing us (the life expectancy of an unhoused person is ~45 right now in LA) allows parks to be used as shelter, and in fact, the LA Parks Foundation list this as one of the main purposes parks serve on their website.

Please stand up for vulnerable people who have nowhere else to go, because without a place to exist, people can't become a part of their neighborhoods, and they can't move forward with their housing or lives.

I became homeless at 13 for the first time. If I weren't sleeping in parks, I probably would have been murdered by now. Allowing City Council to designate LAMC 41.18 zones in City Parks is also a legal jurisdictional issue that Sanitation refuses to clarify and yet is continuing to enforce.

If you need unhoused input (it's my opinion that you absolutely DO) I will offer my advice BUT ONLY IF it is actually heard and not merely sought to make your Commission appear more equitable. I WILL NOT STAND IDLY BY AS HOUSED PEOPLE NEGOTIATE MY RIGHT TO BE IN PUBLIC AWAY.

MOTION

The Venice Pier is a symbol of Los Angeles, and the pier's reconstruction under the leadership of Ruth Galanter is a symbol of the area's revitalization.

Ruth Galanter's tenure on the City Council achieved progress on issues ranging from recycling to sustainable building to fighting airport expansion. While she represented every neighborhood in her district, Venice was her grassroots home and special place in her legacy.

In the mid 1970s, the Venice Pier was closed due to storm damage, and remained closed to the public for more than 13 years. When Ruth Galanter was elected in 1987, a Recreation and Parks employee told her they had located funding to tear down the Venice Pier. Ruth had recently spent years saving the Santa Monica Pier from the same fate, and told the Recreation and Parks Department unequivocally that the pier would not be demolished.

Ruth worked with the community and a grassroots organization headed by Frank Mattox. She brought in the California State Coastal Conservancy to do a feasibility study, and, in 1992, voters passed Proposition A, which included funding for the Venice Pier. At Ruth's insistence, the Proposition A initiators included funding for not only the Venice Pier, but the entire Ocean Front Walk renovation.

Recreation and Parks staff went to bid, hired a contractor, and began the process of tearing down and rebuilding a third of the pier, renovating another, and salvaging the last third. In 1997, the pier was completed and became the first fishing pier in California to be fully accessible.

If it hadn't been for Ruth's commitment, vision, and perseverance, the Venice Pier would not exist today. The honorary naming of the Venice Pier as "Ruth Galanter Pier" would be appropriate recognition for her dedication and service to the Venice community.

I THEREFORE MOVE to request that the Board of Recreation and Parks Commissioners name the Venice Pier "Ruth Galanter Venice Pier."

Obviously, the project has been stopped partway through and I can tell you, that it would go a very long way if you could just share with us what your intentions are and when we can expect to see some progress.

I won't repeat all of my notes from below, but I will update you about the status. Right now, the south side of the park has been (I think unofficially) re-opened. The problem is that there is no water on that side and the drainage has not been repaired there. But on the north side, it is still too rough for wheelchairs and it is dangerously dark in the evenings. The dogs have been digging a deep hole next to the water fountain as it is mud and not the turf that would prevent that from happening. I'm concerned that someone will twist their ankle in that hole. It is also too dark on the path from the north side to the entrance on the south side.

You told be before that you thought the plan was to cover the north side with artificial turf. That is what we are all hoping for and then to fix the plumbing issues as well on the south side.

After that, having adequate light is important and to fix the low fences that tempt the dogs to jump over (sometimes injuring themselves) and pooping out of sight of their owners and getting dirty in poop and mud over there as well.

So many people and dogs use this park. It is a wonderful resource, but has been disappointingly in a state of disrepair for many months.

Please please update us so we know what to expect. At the end of last year, you told just hat you would know more in the beginning of the year. We are already in February.

One more thought, while you're working on this park...

There is a very low fence along the perimeter that separates the landscaping from the dogs' play area. While that looks nice, it does not keep the dogs out of that area. It's fun to watch them all jump that fence, but it's also problematic. I know multiple dogs who have gotten minor injuries from the fence. My dog got a scratch on her belly from the top of the fence. Besides that, it gets muddy over there and the dogs frequently go there to poop and the owners can easily miss that, so the dogs who go over there end up in the poop and the mud. :-0

Ideally, that very low fence would be replaced with a fence that his high enough to keep the dogs out, but still looks nice. Perhaps a 4 foot fence?

Thanks so much for considering this. Besides the mess and inconvenience, it would be a shame for a dog to get more seriously injured in the park.

Hello -

I thought I'd check in for an update. I was happy to see that there is forward progress on the park project! Thank you! However, right now, it seems that the park is less usable than it was and many of the people I know there are upset and will avoid the park until it improves. :-/ I'm sure if we knew what the plan was, we would all feel better. I guess right now, the side without the artificial turf (closer to Glencoe - I'll call this the "north side") was re-opened and the other side, closer to the paddle tennis courts (the "south side") that still needs repair, was closed. The problem now is that the north side is extremely muddy and is riddled with gopher holes which is problematic for our dogs and my friend who uses a wheelchair has no access anymore for her and her dog. Also, there are NO lights in that area, which feels unsafe.

Can you let us know what the plan is?

Here's what we are hoping is planned:

- Remove the old broken drain and water pipe from the south side quickly, then patch and replace the artificial turf in that area so we can return
- Cover the north side with artificial turf as the gopher holes are a hazard and the dirt and mud are a deterrent.
- Install several lights to illuminate the path to and from the park as well as giving us enough light at the park after dark.

Is that, in fact, the plan? Please update us and give us a sense of when we can return to enjoy our park again!

I think there must be some confusion about which project we're discussing. I'm talking about the large dog park at GlenAlla. I will attach photos below, but half of the park is still closed off, locked and inaccessible.

In the area that remains open, there is an overflowing drain that is covered with a tarp and surrounded by orange cones. It is a mess that the dogs continuously get in and try to drink from the overflowing drain.

In the side that remains closed, there is a very large open trench with a piece of furniture covering one very small section, there is the new water fountain that still sits on raised concrete and it's clearly not finished. There is caution tape and piles of dirt. In short, there can be no doubt that the project is not completed. As I explained before, part of the frustration is that there seems to be very little work completed on an ongoing basis and no communication as to when the park will reopen.

Thanks again for your help with this. I hope this more detailed email and the attached photographs are helpful in understanding its current status.

Thanks for your patience and communication in regards to the issues at the dog park. The latest information I have is that park maintenance and contractors have been notified of the issues remaining at the park, specifically the requests from the public to keep the majority of the natural turf area synthetic, and to cover exposed areas of the north side of the park with more synthetic turf. Also, our construction teams have asked maintenance to remove the sump and water fountain in its entirety and replace it, as the sump keeps clogging up, which is causing the drainage issues you mentioned.
