1. Approve the scope of work and total budget for the Eagle Rock Recreation Center - Playground and Outdoor Fitness Equipment Replacement (PRJ21575) Project (Project), as described in the Summary of this Report;
2. Approve the proposed Project to be bid and constructed through the Department of Recreation and Parks' (RAP) list of pre-qualified on-call contractors;
3. Approve the authorization of change orders as authorized under Report No. 06-136, for the construction contracts for this proposed Project in the budget contingency amounts for such contracts as stated in this Report;

4. Determine that the proposed Project is categorically exempt from the provisions of the California Environmental Quality Act (CEQA) pursuant to Article III, Section 1, Class 1(3) [Maintenance and minor alteration of existing pedestrian trails]; Class 2 [Replacement of existing structures where the new structure will be located on the same site as the structure replaced and have substantially the same purpose and capacity], and Class 11(6) [Placement of minor structures accessory to (appurtenant to) existing institutional facilities] of City CEQA Guidelines and Article 19, Sections 15301(c), 15302 and 15311 of California CEQA Guidelines and direct RAP staff to file a Notice of Exemption (NOE) with the Los Angeles County Clerk;
5. Authorize RAP's Chief Accounting Employee or designee to prepare a check to the Los Angeles County Clerk in the amount of \$75.00 for the purpose of filing a NOE; and,
6. Authorize RAP staff to make technical corrections as necessary to carry out the intent of this Report.

SUMMARY

Eagle Rock Recreation Center is located at 1100 West Eagle Vista Drive in the Eagle Rock community of the City. This 20.68-acre park features a community center, childcare center, children's play areas, multipurpose fields, tennis and basketball courts, outdoor fitness equipment, and a dog park. An estimated 1,750 City residents live within a one-half mile walking distance of Eagle Rock Recreation Center. Due to the facilities and features it provides, Eagle Rock Recreation Center meets the standard for a Community Park, as defined in the City's Public Recreation Plan.

PROJECT SCOPE

The scope of work for the proposed Project includes the following:

- The demolition and removal of the existing play area.
- The installation of a new play area and safety surfacing with integrated shade toppers.
- Installation of a new hydration station.
- Park pathway and path of travel improvements.
- The demolition of the existing outdoor fitness equipment.
- The installation of new fitness equipment and safety surfacing.

Renderings of the proposed play area and fitness equipment are attached to this Report.

PROJECT FUNDING

The 2021-22 Adopted Budget included Seventy-Five Million Dollars (\$75,000,000.00) in the Unappropriated Balance for RAP to make capital improvements at City parks and facilities (Council File No. 21-0935). In response, RAP developed a capital improvement plan to utilize the \$75,000,000.00 in funds to complete various park projects citywide. The Project is one of the park projects that RAP has identified for the use of these funds.

Additionally, the Los Angeles City Council awarded Seven Hundred Eighty-Six Thousand Dollars (\$786,000.00) in AB1290 Funds (Council File No. 20-0371) to the proposed Project.

The total amount of funding for the proposed Project is One Million, Six Hundred Ten Thousand Dollars (\$1,610,000.00), which will be the total budget for this Project, inclusive of the budget contingency amounts set forth below.

The anticipated pre-qualified on-call contracts for this Project will be for Playgrounds and Outdoor Fitness/Exercise Equipment. The budget contingency amount for the Playgrounds Contract will be Eighty Thousand Dollars (\$80,000.00). The budget contingency amount for the Outdoor Fitness/Exercise Equipment Contract will be Fifty Thousand Dollars (\$50,000.00).

These Park Fees were collected within five (5) miles of Eagle Rock Recreation Center, which is the standard distance for the commitment of the Park Fees for community recreational facilities pursuant to Los Angeles Municipal Code Section 12.33 E.3.

PROJECT CONSTRUCTION

RAP staff has determined that sufficient funding has been identified and construction for the proposed Project is anticipated to begin in Summer 2022.

TREES AND SHADE

This proposed Project will have no impact on the existing trees at Eagle Rock Recreation Center. The new fitness equipment includes a shade component. The new playground will include integrated shade toppers.

ENVIRONMENTAL IMPACT

The proposed Project consists of maintenance and minor alteration of existing pedestrian trails; replacement of existing structures where the new structure will be located on the same site as the structure replaced and have substantially the same purpose and capacity, and placement of minor structures accessory to (appurtenant to) existing institutional facilities.

According to the parcel profile report retrieved on May 3, 2022, this area is not located in a liquefaction zone. This site is not within a coastal or methane zone, so there is no reasonable possibility that the Project may impact on an environmental resource of hazardous or critical concern or have a significant effect due to unusual circumstances. No other known projects would involve cumulatively significant impacts, and no future projects would result from the proposed project. As of May 3, 2021, the State Department of Toxic Substances Control (DTSC) (Envirostor at <https://www.envirostor.dtsc.ca.gov/public/>) and the State Water Resources Control Board (WRCB) (Geotracker at <https://geotracker.waterboards.ca.gov/>) has not listed the proposed Project site or any contaminated sites near the proposed Project area (within 500 feet). According to the Caltrans Scenic Highway Map there is no scenic highway located within the vicinity of the proposed Project or within the project site. The project is not located in proximity of Eagle Rock Playground Clubhouse, a City of Los Angeles Historic Cultural Monument (HCM# 536), but replacing the existing playground and fitness equipment will not cause a substantial adverse change in the significance of that historical resource.

Based on this information, RAP staff recommends that the Board of Recreation and Park Commissioners (Board) determine that it is categorically exempt from the provisions of the California Environmental Quality Act (CEQA) pursuant to Article III, Section 1, Class 1(3), Class 2 and Class 11(6) of City CEQA Guidelines and Article 19, Section 15301(c), 15302 and 15311 of California CEQA Guidelines. Staff will file a Notice of Exemption with the Los Angeles County Clerk upon Board's approval.

FISCAL IMPACT

The approval of this Report will have no fiscal impact on RAP's General Fund. The estimated costs for the design, development, and construction of the proposed park improvements are anticipated to be funded by Deferred Maintenance funds, AB1290 funds or funding sources other than the RAP's General Fund. The maintenance of the proposed park improvements can be performed by current staff with no overall impact to existing maintenance service at this facility.
