RECOMMENDATIONS

1. Approve the Wilmington Town Square Park - Phase II Improvements Project (Project), as described in this Report;
2. Authorize the Department of Recreation and Parks (RAP) to issue the appropriate Right-of-Entry (ROE) permit(s) for the Project;
3. Determine that the Project is categorically exempt from the provisions of the California Environmental Quality Act (CEQA) pursuant to Article III, Section 1, Class 11(5) [Signs located on City property managed by a City department which has a sign policy adopted by its Board of Commissioners] and Class 11(6) [Construction or placement of minor structures accessory to (appurtenant to) existing institutional facilities] of City CEQA Guidelines as well as to Article 19, Section 15311 of California CEQA Guidelines and direct staff to file a Notice of Exemption (NOE) with the Los Angeles County Clerk;

SUMMARY

The Wilmington Town Square Park Project is located at 105 W. I Street in the South Los Angeles community of the City. This 0.48-acre park include benches and open grass areas for passive recreation. Approximately 8,388 City residents live within a one-half mile walking distance of the Wilmington Town Square Park. Wilmington Town Square Park was designed and constructed by the Los Angeles Neighborhood Initiative (LANI) and construction was completed in Summer 2020.

PROJECT SCOPE

LANI approached RAP about the completion of the Wilmington Town Square Park – Phase II Improvements Project, which includes the following scope of work:

- Installation of six (6) security cameras and related electrical work
- Installation of a mosaic mural in the arches of the park.
- Installation of eighteen (18) historic plaques throughout the park.

LANI was awarded Five Hundred Thousand Dollars (\$500,000.00) by the City of Los Angeles for the completion of the Project (CF #20-0600-S83).

Security Cameras

This portion of the Project will include the installation of a total of six (6) security cameras, including the electrical support to install cameras. LANI coordinated with RAP regarding the design and location of the security cameras and will be utilizing one of RAP's on-call contractors for the installation.

Mosaic Mural

The proposed Project includes the installation of a mosaic tile art decoration named "Wilmington Town Square Mosaic", an interactive art installation highlighting the diverse history of the South Los Angeles community. This mosaic will include a colorful mosaic decoration created by school children and installed by an artist named Katy Krantz. Katy Krantz will conduct an art educational program at Wilmington Youth Center and will include weekly sessions for eleven (11) weeks. Curriculum will emphasize autobiographical storytelling and will explore 4 units: (1) drawing, (2) painting, (3) collage/poetry, and (4) digital media. Each unit will include an opportunity to make ceramic tiles that will be incorporated into the overall design of the mosaic mural to be installed on arches. Renderings of the proposed Project are shown in Attachment 1. The mosaic mural will be installed for a period of ten (10) years.

On August 12, 2022, the Los Angeles Neighborhood initiative (LANI) issued a Request for Proposal (RFP) to several Art Project Management and Outreach Vendors and received a proposal from Green Communications Initiative (GCI) that they found acceptable. After rounds of negotiations, it was decided that GCI is providing the artistic directions of the mosaic process. Their proposal included working with Mosaic Artist, Katy Krantz.

Katy Krantz is a long term resident of Los Angeles with a deep investment in building community. Her artwork has been exhibited internationally and featured in prominent publications such as the Santa Cruz Sentinel, the San Francisco Chronicle, and the Seattle Times. All of the artists that will be supporting Krantz to work on this project are from the Wilmington community.

Avalon Arts & Cultural Alliance will be responsible for full and complete maintenance of this project for the full ten (10) years of its duration. The mosaic will not be covered in anti-graffiti coating as the artist has advised that it will cause discoloration to the tiles.

The visual content linked to the QR code shown on the arches will be accessible and located on a third party platform. There will also be a 7"x4.5" plaque near the mosaic that will state, "You may scan the QR Code to learn more about the youth participants in this project. Please note that use of this QR Code links to a website that is not maintained by or under the control of the City of Los Angeles".

RAP has received the requisite artist waiver and has the right to remove the mosaic and related QR codes if the mosaic or QR codes links are not maintained at any time.

Historic Plaques

There are eighteen (18) Wilmington historical plaques that were presented and approved by community members and the Office of Council District 15. The plaques will be made of bronze, measuring 10"x"10 with an additional "Date" rectangular plaque beneath that measures 10"x4". Braille will also be included with the plaques to assist those who are visually impaired.

The language for each plaque and the proposed locations are shown in Attachment 2.

On September 1, 2022, the Facility Repair and Maintenance Commission Task Force (Task Force) granted conceptual approval of the proposed Project. In addition, on September 14, 2022, the Department of Cultural Affairs' Cultural Affairs Commission (CAC) approved both the mosaic mural and the historic plaques. The CAC Agenda is shown as Attachment 3.

TREES AND SHADE

This proposed Project will not impact shade at Wilmington Town Square Park.

ENVIRONMENTAL IMPACT

The proposed Project consists of signs located on City property managed by a City department which has a sign policy adopted by its Board of Commissioners and construction or placement of minor structures accessory to (appurtenant to) existing institutional facilities.

According to the parcel profile report retrieved October 11, 2022, this area resides in a methane zone, but since the proposed activities will take place outdoors the proposed Project will not increase the risk associated with methane seepage. The site is not in the liquefaction, historic or

coastal zone so there is no reasonable possibility that the proposed Project may impact on an environmental resource of hazardous or critical concern or have a significant effect due to unusual circumstances. No other known projects would involve cumulatively significant impacts, and no future projects would result from the proposed Project. As of October 11, 2022, the State Department of Toxic Substances Control (DTSC) (Envirostor at www.envirostor.dtsc.ca.gov) and the State Water Resources Control Board (SWCB) (Geotracker at <https://geotracker.waterboards.ca.gov/>) have not listed the Project site, but have listed RB Case #: 907440107 near the Project area (within 500 feet). The case regards a leaking underground storage tank at a fire station. The Regional Quality Control Board closed the case in 1996 and this office does not expect the proposed project could affect soil quality. According to the Caltrans Scenic Highway Map there is no scenic highway located within the vicinity of the proposed Project or within its site. Furthermore, the proposed Project is not located in proximity of a known historical resources and will not cause a substantial adverse change in the significance of any historical resource.

Based in this information, staff recommends that the Board of Recreation and Park Commissioners (Board) determine that it is categorically exempt from the provisions of the California Environmental Quality Act (CEQA) pursuant to Article III, Section 1, Class 11(5) and Class 11(6) of City CEQA Guidelines as well as to Article 19, Section 15311 of California CEQA Guidelines. Staff will file a Notice of Exemption with the Los Angeles County Clerk upon Board's approval.

FISCAL IMPACT

The approval of this Report will have no impact on RAP's General Fund. The proposed Project will be paid for by LANI.

Dear RAP Board of Commissioners,

I am reaching out to provide more narrative information regarding the Los Angeles Neighborhood Initiative's (LANI) proposal for improvements to Wilmington Town Square Park, located at 105 West I Street Wilmington, CA 90744. LANI originally led the development efforts to improve Wilmington Town Square Park in 2020.

LANI currently has a contract in place with CD-15 and Korean Youth + Community Center (KYCC) to produce beautification and improvement elements to Wilmington Town Square Park, including Mosaic tile decoration additions to the interior arches of the Stage Area, New Camera Surveillance System, and 18 Historic Plaques throughout the park.

Per the requirements in the Public Art Application, I am providing detailed information for the required items in Section D. of the Public Art Application:

1. **Funding Source-** LANI received \$500,000 from CD-15 as funded by CF 20-0600-S83 through KYCC OCB Contract No. 00304. With this funding LANI will be contracting vendors to assist in camera surveillance installation including electrical work required, Artist and Community Outreach for Mural and Mosaic elements, and Historic Plaques installation.
2. **Artist Selection Process:** LANI put out a Request for Proposal to several Art Project Management and Outreach Vendors and received a proposal from Green Communications Initiative (GCI) that they found acceptable after rounds of negotiations.
 - a. GCI is providing the Artistic directions of the Mosaics process. Their proposal included working with Mosaic Artist, [Katy Krantz](#), to provide the following components:
 - i. A no cost curriculum to undeserved youth that will ultimately culminate in a collaborative tile mosaic decorations on the square's arches.
 - ii. A source of pride for the Wilmington Community. Community Members will have an opportunity to decide on the theme of the Mosaic Tiles project via a series of public meetings, directed by LANI.
3. **Design:** The initial Design depends completely on the Wilmington Communities input/direction as to what themes and color palettes. LANI Program Manager developed a community survey and dispersed to members involved in the WTS Phase I Project as well as other identified community stakeholders where survey participants voted on what color palette and theme they wanted to see included in the Mosaics tiles themselves. LANI also set up the first of several community meetings at the Wilmington Farmers Market on May 26th, where the project was discussed to the community, survey and voting occurred in person. Once the survey was closed,

there were over 50 participants from the community that chose the color palette and themes. This now informed the design and approach to the mosaic and mural elements detailed below:

- a. *Mosaics-Tile*: Lead Artist Katy Krantz will be conducting an art educational program at the Wilmington Youth Center and will include weekly sessions for 11 weeks. With the supervision of Katy Krantz, students will create the mosaic-tile design that will be installed into the park itself. Curriculum will emphasize autobiographical story telling and will explore 4-units: (1) drawing, (2) painting, (3) collage/poetry, and (4) digital media. Each unit will include an opportunity to make ceramic tiles that will be incorporated into the overall design of the mosaic mural to be installed on arches.
4. **Community Context**: As discussed above community engagement, outreach, and overall input is vital to the design and direction of this project. CD-15 gave substantial direction of the existing environment in terms of size and color, and will work with winning mural artist, and our lead artist to ensure art installation process is smooth and unobstructed.
5. **Production Process**: Artist Katy Krantz will continue the community outreach element within the scope of her work, developing the mosaic tiles with the Wilmington Youth Center, as well as conducting multiple “pop-ups” at the park for community members to contribute their mosaic tiles to the overall design. This will continue again in the fall, with completion in early October, where Katy Krantz will then transition to the actual installation of the mosaics in the arches.
6. **Lifespan of Project & Maintenance**:
 - a. **Avalon Arts & Cultural Alliance** will be responsible for full and complete maintenance of this project.
 - b. The Los Angeles Neighborhood Initiative will provide maintenance funding to the Avalon Arts & Cultural Alliance, who will provide direct maintenance for the full 10 years of the lifespan of this project, including directly paying for maintenance for the next ten year.
 - c. We asked the artist to provide detailed maintenance necessities to ensure the lifespan of the project and LANI has set aside a budget to ensure proper maintenance of the project that we are transferring to Avalon Arts & Cultural Alliance, as well providing the information below for maintenance requirements. Please see below:
 - i. 10+ year lifespan (tiles can last even longer than 10 years)
 1. No anti-graffiti coating -- it discolors and/or yellows tile.
 2. No power washing (loosens tile grout and can gouge/pit tile)
 - ii. Regular Maintenance: tiles can be cleaned 1x per year with microfiber cloth dampened with water. No special cleaner necessary.
 - iii. Anti-graffiti Maintenance
 1. steel wool (fine) or wire brush with any one of the following:
 2. baking soda + water OR
 3. "Goof Off" OR "Bar Keepers Friend" + water
 - iv. Vandalism Maintenance (damage from breaking/removal):
 - v. \$500/sq. foot/replacement of tiles
 - d. Artist guarantee of work: 1 year excluding graffiti and/or vandalism. (For example, replacement of a tile that spontaneously falls off in Year 1). After Year 1, \$500/sq. ft.



Wilmington Town Square Phase 2- Historical Plaques Element Proposal:

The following are the proposed 18 Wilmington Historical Facts that were selected through a thorough community engagement process, and voted on by Steering Committee members, which included CD-15 Staff, and the Wilmington Historic Society in 2020.

The wording provided below is exact for each plaque in numerical sequential order, with the date/year preceding the wording as the date/year that will go into the date/year section of the plaque per the design.

The overall design of each plaque is the same in size and layout. Each plaque will be bronze, and sizing of each plaque is 10"x10" Square sizing for the above lettering portion of the plaque, with an additional 4"x 10" Rectangular sizing for each Historical Date/Year portion of the plaque.

Lettering of the exact wording below for each plaque will be adjusted in font to fit within that standard and same sizing for each plaque sizing where necessary. All plaques will include brail at the bottom of their wording to account for potential park visitors that may be visibly disabled/handicapped.

1) Pre-1751 : For thousands of years prior to the arrival of Spanish explorers, the **Tongva-Gabrieleño Native American people** inhabited the nearby peninsula and likely fished and hunted in present day Wilmington.

2) October 8, 1542: **Juan Rodriguez Cabrillo**, an explorer for the Spanish Empire, sailed into the San Pedro Bay and named it for St. Peter of Alexandria, a Fourth Century bishop in Alexandria, Egypt.

3) 1784: **Juan Jose Dominguez**, a Spanish soldier, was granted 75,000 acres by King Charles III of Spain. This became known as **Rancho San Pedro**. (map of what is now San Pedro, the Palos Verdes peninsula, Torrance, Redondo Beach, Hermosa Beach, Manhattan Beach, and east to the Los Angeles River, including the cities of Lomita, Gardena, Harbor City, **Wilmington**, Carson, Compton, and western portions of Long Beach and Paramount).

4) 1854: In preparation for the transcontinental railroad, **Phineas Banning** led a group of investors in the purchase of 2,400 acres from the Dominguez family.

5) On September 25, 1858, the first freight and passengers were unloaded at Banning's Landing, becoming **the birthplace of America's Port®**. The town was originally called New San Pedro and the city became **Wilmington in 1863**, named by Phineas after his Delaware birthplace.

6) April 12, 1861: The Civil War began, and Wilmington became the army headquarters for California and the Arizona Territory. The 60-acre **Drum Barracks** consisted of 22 buildings and served as the protector of the harbor and the supply depot for the Western forts. In 1862, 2,350 soldiers marched from Wilmington to New

Mexico to force invading Confederate soldiers back into Texas. The Drum Barracks is a City, State, and National Historic Landmark.

7) 1864: The construction of the **Banning residence** was completed. The home sat on 222 acres and was a working ranch. Phineas was a California state senator, brigadier general in the Civil War, referred to as the "Father of the Los Angeles Harbor". The Banning Residence is a City, State, and National Historic Landmark.

8) January 12, 1869: **The San Gabriel** became the first locomotive engine in Southern California and was used in the construction of the Los Angeles and San Pedro Railroad, which Phineas Banning opened on September 8, 1869. This was the **first railroad in Southern California** and ran from Banning's Landing to downtown Los Angeles. Banning's Landing became the southern terminus of the transcontinental railroad.

9) 1904: The arrival of the **Pacific Electric Railroad** provided Wilmington with a quick and affordable connection to Los Angeles, ending its isolation and growing its population, business, and civic organizations.

10) 1908: Wilmington City Hall was built on the site of present-day Wilmington Town Square Park. Residents voted in favor of incorporation as an independent city in 1905. The building served as the City of Wilmington's city hall for just a little more than a year, after which it became the Wilmington Municipal Building when annexed into the City of Los Angeles. It was later condemned and demolished after being severely damaged in the 1933 Long Beach earthquake.

11) June 8, 1909: By an affirmative vote of 107 to 61, **Wilmington was annexed** into the City of Los Angeles in hopes of acquiring new schools and libraries, police and fire services, harbor improvements, and improved water supplies.

12) 1919: Following **William Wrigley Jr.**'s purchase of Catalina Island to use as a training camp for his Chicago Cubs, he purchased land adjacent to the Banning residence to build what he called "**the Court of Nations**". Wrigley then built the **Catalina Terminal** and the **Wilmington Catalina Airline** at Banning's Landing.

13) 1920s: **California Yacht Club** was constructed at Berths 193-194 in 1922 and was a playground for wealthy businessmen and celebrities during the roaring '20s. Members of the Yacht Club won the first U.S. gold medal in sailing in the 1932 Olympics in a boat constructed by the **Wilmington Boat Works**. The **Don Hotel** was constructed in 1929 and hosted travelers to Catalina during the '30s and '40s, including Bing Crosby and William Randolph Hearst.

14) 1929: Claude Preston Roberts launched the **Wilmington Press daily newspaper**. The publication was one of the greatest contributors to creating a sense of community in Wilmington.

15) January 24, 1942: Wilmington was the home of the **Los Angeles Port of Embarkation** during World War II. Over 200,000 soldiers flowed through the Port and Wilmington was the home to one of the largest shipbuilding yards, the Consolidation Steel Corporation, located on 95 acres at Neptune Avenue and B Street.

16) 1933: **The Longshoremen of Wilmington, ILA & ILWU**: There have been many large employers in Wilmington, such as the Ford plant, Consolidated Steel Company, Starkist, and Borax, etc. but none compared to the impact and longevity that the longshoremen have had on the fabric of the Wilmington community.

The mural design was created as a collaboration between two selected muralists - one African American and one Latina, and the youth at South Park's summer camp. Arts Bridging the Gap and the muralists conducted art workshops that included games, discussions, and art-making. These activities allowed for free expression and thought-provoking understandings, so that the muralists could see through the communities' eyes and gain a deeper perspective on how to make a public art piece meaningful for everyone in the neighborhood. In addition to working with the youth, Arts Bridging the Gap also spoke with adult community members about the history of the park to infuse the history into the art piece. 11:11 A Creative Collective, Inc. commissioned artist Jason Chang (aka RFX1), to create a mural entitled “Neighborly Growth” as one of eight (8) murals featured in the April 2022 Reseda Rising Mural Festival. The mural is painted on the exterior south wall of the ONEgeneration Senior Enrichment Center and measures 160’ in length and 15’ in height.

The mural received Conceptual and Final Approval from the Cultural Affairs Commission (CAC) on May 11, 2022. The CAC staff report stated that “The Department of Cultural Affairs in partnership with the Council Office and Office of Community Beautification will be the primary stewards of the mural’s maintenance,” however, that statement was incorrect.

This report aims to correct that error and memorialize the agreement in place, pursuant to subsequent conversations between the applicant, Department of Cultural Affairs (DCA), and the Department of Recreation and Parks (RAP), that ONEGeneration will be responsible for the maintenance of the mural.
